The Wednesday 10 a.m. meeting is doing well; both have solid recovery, both with varied agendas with a variety of literature. The Sunday 9:30 a.m. meeting needs support. Barbara said the 6 p.m. Monday Detroit Unity meeting is doing well with about 7-8 people. The Sinai meeting at 10:30 a.m. Saturday has 3-5 people and needs support.
